RULES AND REGULATIONS

1. Name of Society :- JIJAMATA EDUCATION SOCIETY, NANDURBAR.
2. Address of Society :- Jijamata Education Society, 115, Girivihar Colony, Nandurbar, Dist Nandurbar. 425 412.
3. Area of Operation :- Maharashtra State.
4. Financial Year of the Society :- 1 April to 31 March

5. Membership :- Person over the age of 18 years can be member of Society
 - I) Life member :- The person who donates Rs.1001/-
 - II) General Member :- The Person who donates Rs.51/- per year with Rs.11/- as Admission fee.
 - III) Conditions for members :-
 - a) Members should apply in the specimen form of Society Related donation and fees should be submitted to president/Secretary in cash.
 - b) Membership will be valid only after scrutinisation and acceptance by Working committee. That is to offer membership is right of working committee.

6. Reason for the cancellation of Membership.

- 1) Sad demise of member.
- 2) Resignation by member and the acceptance of the same by the Executive committee.
- 3) Absence on five consecutive meetings called by working committee. Also absence with out prior, permission for continuous one year.
- 4) If court declares member as Bankrupt
- 5) If member is convicted by court for Ethical or Civil crime.
- 6) If member do not obey rules of Trust of works against the interest of Society

Notes:- Above Rules and Regulations are also applicable to Working Committee.

7) Executive committee :-

The first working committee after Registration of Trust. will act for five years. working committee members are reelected every five years from general members. Members of working committee, then elects President, Vice-President, Secretary and Treasure among them by majority.

Working Committee will be elected by secret ballot method. working committee will comprise of minimum seven or at maximum eleven members. If a Post is vacated by any reason before term of working committee it will be fulfilled on the basis of Co-op.

8. Meeting of Working Committee:-

Working committee members will meet at least three times a year. Minimum 4 members will be quorum of meeting, in case of 7 members will be quorum of meeting in case of 11 members working committee. If meeting is suspended because of less number of quorum, then meeting will start again at same place after half hour subjects other than mentioned in minutes of the meeting can not be discussed. Notice of the meeting will be send eight days in advance to members by U.P.C.

9. Annual General meeting :-

- 1) Annual General meeting will be held within two months after closing of Financial Year of Trust. This meeting will be called as special general meeting.
- 2) For both the meetings all members will be informed by notice ten days in advance either by post or by hand mentioning the date, place & time of meeting.

10. Minutes of Annual General meeting :-

- 1) To sanction the details & decisions of past meetings by reading.
- 2) To Sanction annual Budget by discussing Balance-sheet Report.
- 3) To sanction annual expences & annual Report of Society. To sanction integral and startegic resolution of Society.
- 4) To elect working committee if term is cover (For next five years)
- 5) To appoint auditor of C.A. and fix his remuneration.
- 6) To take decisions, after discussing problems or subjects rising at the very time of the meeting.
- 7) To revise Rules and Regulations if needed according to changing situations. Discussions of dissolution of Society will be made in Annual general meeting.
- 8) To sale or purchase fixed assets and to construct the building on the same.
- 9) To appoint sub-committee other functions of Society and Grant right of same to working committee
- 10) To give right to working committee for appointing staff in schools or colleges of Society. To take care for avoiding any injustice to staff as per Governments rules and Regulations.

11) Decision :-

Any decision in any meeting will be taken by the majority, but in case of equality, President will cost the coasting vote.

12. Chairmanship :-

Annual general meetings, Special general meeting, meeting of working committee & meetings held from time will be chaired by President of Society. In case of President, Vice-President will chair the meetings & in absence of both secretary will conduct the meeting But in absence of all three, a persons who is member of working committee is suggested by President will conduct the meetings.

13. Meeting Summary :-

Summary of Working committee meetings and summary of General and special meetings will be mentioned in to two separate books. The same will sanctioned in the next meeting.

14. Functions of Members :-

- 1) To accept chairmanship, to direct and conduct all meetings properly.
- 2) To control all activities of Society.
- 3) To use right of decisive vote in case of equal votes situations.

II) VICE-PRESIDENT

- 1) To assist President in conducting all the meetings.
- 2) To control activities of Society in absence of President.

III) TREASURER

- 1) To assist Secretary .
- 2) To supervise financial transaction.

IV) On the behalf and reponsibility of working committee, Secretary will perform daily routine activities of Society & following functions.

- 1) To keep account of transaction of Society in assistance with President.
- 2) To supervise and control security of Asset of Society
- 3) To write or get written Summary of all meetings.
- 4) To keep and maintain records, to prepare and correspondence on the behalf of working committee by taking it into Society.
- 5) To act or get work done in the levels and rights provided by working committee.
- 6) To keep Rs.500/- for daily expenses and give record or explanation of it if asked by President or Vice-President or Member of working committee.

15. Financial transaction :-

Funds coming to the Society will be deposited in the account of trust in a Nationalised Bank or Scheduled Bank or Bank recognized by Schedule -15 or Post. Such account will run by joint signatures of President and Secretary or President and Treasurer.

16. Funds of Society :-

Society funds will be raised as follows.

- 1) By accepting donations.
- 2) Accepting government or Semi-government grants.
- 3) Arranging charity or sports shows & Entertainment Programs
- 4) Arranging Lucky draws.
- 5) Miscellaneous.

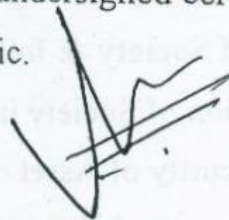
17. Changing Rules and Regulations :-

It is done as per new rules, in Annual general meetings or special general meetings by 2/3rd majority. But change in objects will be done as per Schedule-12 Society Registration Act-1860.

18. Dissolution of Society :-

Society Registration Act will be 1860 Schedule-13 and 14 will be followed in case of dissolution of Society. The same will be informed to Assistant Registrar. Similarly, after paying all credits and remaining funds or Assets will be dissolved in to Society with common objects and registered as per Society. Registration Act-1860.
